

**OVERVIEW OF TESTING CONDUCTED BY PROSOCO, Inc.  
FOR CENTURION STONE INC., NASHVILLE, TN  
Project No. 0404-14 PTP**

Eight types of simulated stone were submitted to PROSOCO Inc.'s Testing Laboratory with a request to determine if the products effectively cleaned the simulated stone without producing any surface alterations during new construction cleaning operations. Additionally, the effectiveness of water repellents, stain repellents, and graffiti repellents were evaluated.

**New construction cleaning** was performed using PROSOCO's new construction cleaners to evaluate effective removal of excess mortar and related new construction soiling. **Surface Alteration** on the simulated stone was evaluated visually based upon perceived discoloration/etching of the submitted samples. **Protective Water Repellent** testing was performed to evaluate water repellency provided by PROSOCO's water repellents. **Stain Repellency** testing was conducted to determine which PROSOCO product(s) are most effective at repelling and facilitating the removal of stains. **Graffiti Control** testing was evaluated to determine which PROSOCO product(s) are most effective at repelling and facilitating the removal of graffiti; in addition to determining the most effective product to remove graffiti from treated and untreated samples.

The attached report provides information about the PROSOCO products tested and descriptions of the test methods. The report includes test results as well as conclusions and recommendations. Recommendations for cleaning, surface alterations, water repellent, graffiti control, and stain repellency treatments are also provided in the chart below.
