Overview of Testing Conducted By PROSOCO, Inc. Town & Country Landscape Supply, Markham, IL Project No. 0512-01

Four types of unpolished marble were submitted to PROSOCO, Inc.'s Testing Laboratory with a request to determine if application of the evaluated cleaners will produce any surface alteration for unpolished marble were during new construction cleaning operations. Additionally, the effectiveness of water repellents, stain repellents, and color enhancement products suitable evaluated. **Limiting Surface Alteration** testing was performed to evaluate discoloration or erosion/etching of the samples during new construction cleaning operations. **Protective Water Repellent** testing was performed to evaluate water repellency provided by PROSOCO's water repellents. **Stain Repellency** testing was conducted to determine which PROSOCO product(s) are most effective at repelling and facilitating the removal of stains. **Color Enhancement** was evaluated for its ability to provide color enhancement to the submitted samples. The attached report provides information about the PROSOCO products tested and descriptions of the test methods. The report includes test results as well as conclusions and recommendations. Recommendations are also provided in the chart below.
