Four types of concrete brick, all with large, small and fine aggregate were submitted for testing to AMT Laboratories by PROSOCO, Inc. to determine the optimal concentration of cleaner for complete removal of mortar and related new construction soiling which also leaves the external surface looking most like the uncleaned surface of the concrete brick. Additionally, the effectiveness of water repellents and graffiti control products were evaluated. **New Construction Cleaning** was performed to evaluate the effectiveness of the selected PROSOCO products at removing excess mortar, and related new construction soiling, while limiting potential surface alterations to the finish. **Protective Water Repellent** testing was performed to evaluate which PROSOCO water repellent(s) are most effective at providing protection from wind driven rain. **Graffiti Control** products were evaluated for its ability to repel and remove graffiti from the submitted samples.

The attached report provides information about the PROSOCO products tested and descriptions of the test methods. The report includes test results as well as conclusions and recommendations. Recommendations are also provided in the chart below.
