

## Basalite Concrete Products Dixon, CA

## **Executive Summary**

Project No. 1808-08

Ten CMUs (2 Smooth, 2 Split Face, 2 Ribbed, 2 WR Smooth, 2 WR Ground Face) were submitted to AMT Laboratories by PROSOCO, Inc. with a request to determine the most appropriate new construction cleaner. Additionally, the effectiveness of water repellent and graffiti resistance products suitable for vertical concrete was evaluated.

The laboratory report (1808-08 PTP Basalite Concrete Products) provides information about the PROSOCO® products tested and descriptions of the test methods. The report includes test results as well as conclusions and recommendations. Recommendations are also provided in the chart below.
