Executive Summary

Project No. 2008-04

Thirty-six types of granite samples were submitted to AMT Laboratories by PROSOCO, Inc. with a request to determine the most appropriate new construction cleaner and maintenance cleaner. Additionally, color and sheen enhancement, water repellent, graffiti resistant, stain resistant, and stain removal (adverse effects) products suitable for granite were evaluated (where applicable).

The laboratory report (2008-04 PTP Coldspring) provides information about the PROSOCO® products tested and descriptions of the test methods. The report includes test results as well as conclusions and recommendations. Recommendations are also provided in the chart below.
