Three types of samples (two CMUs and one concrete brick) were submitted to AMT Laboratories by PROSOCO, Inc. with a request to determine the most appropriate urine resistant product. Additionally, color and sheen enhancement and water repellency were evaluated for the selected products.

The laboratory report (2101-04 PTP County Materials Corporation) provides information about the PROSOCO® products tested and descriptions of the test methods. The report includes test results as well as conclusions and recommendations. Recommendations are also provided in the chart below.
