Executive Summary

Project No. 2404-01

Eleven types of concrete pavers were submitted to AMT Laboratories by PROSOCO, Inc. with a request to determine the most appropriate new construction cleaner. Additionally, stain removal, color and sheen enhancement, water repellent, and stain resistant products suitable for concrete pavers were evaluated.

The laboratory report (2404-01 PTP Castohn) provides information about the PROSOCO® products tested and descriptions of the test methods. The report includes test results as well as conclusions and recommendations. Recommendations are also provided in the chart below.
