4. FIRST AID MEASURES

First aid measures**General advice**

Immediate medical attention is required. If symptoms persist, call a physician.

Eye contact

Immediate medical attention is required. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Keep eye wide open while rinsing. Do not rub affected area. Call a physician.

Skin Contact

Wash off immediately with plenty of water while removing contaminated clothing and shoes. If skin irritation persists, call a physician. Wash contaminated clothing before reuse.

Inhalation

Remove to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. Call a physician or poison control center immediately.

Ingestion

Do NOT induce vomiting. Rinse mouth. Drink plenty of water. Never give anything by mouth to an unconscious person. Remove from exposure, lie down. Call a physician or poison control center immediately.

Self-protection of the first aider Use personal protective equipment as required. Avoid contact with skin, eyes or clothing.

Most important symptoms and effects, both acute and delayed

Symptoms Corrosive to eyes. Causes severe burns. Skin corrosion.

Indication of any immediate medical attention and special treatment needed

Note to physicians Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Use. Dry chemical. Carbon dioxide (CO₂). Water spray (fog). Alcohol resistant foam.

Unsuitable Extinguishing Media Caution: Use of water spray when fighting fire may be inefficient.

Specific hazards arising from the chemical

In the event of fire and/or explosion do not breathe fumes. The product causes burns of eyes, skin and mucous membranes. Thermal decomposition can lead to release of irritating and toxic gases and vapors. Keep product and empty container away from heat and sources of ignition. Risk of ignition.

Protective equipment and precautions for firefighters

As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear.

6. ACCIDENTAL RELEASE MEASURES

Methods and material for containment and cleaning up

Methods for containment Prevent further leakage or spillage if safe to do so. Dike far ahead of liquid spill for later disposal.

Methods for cleaning up Dam up. Prevent product from entering drains. Soak up with inert absorbent material. Pick up and transfer to properly labeled containers. Clean contaminated surface thoroughly. After cleaning, flush away traces with water.
